NHS Lanarkshire Independent Health Care Providers and the contract monitoring arrangements

“The Care Commission is responsible for regulating the independent healthcare sector and securing quality of care. However, certain services are not subject to regulation. The quality of these services must be monitored through the contract management process. The care Commission has a responsibility to all patients in the independent sector, whether or not their treatment is funded by the NHS. The Commission provides external monitoring of independent healthcare providers to ensure they provide appropriate standards of service. It also investigates complaints about services and allegations that standards have not been met.”
